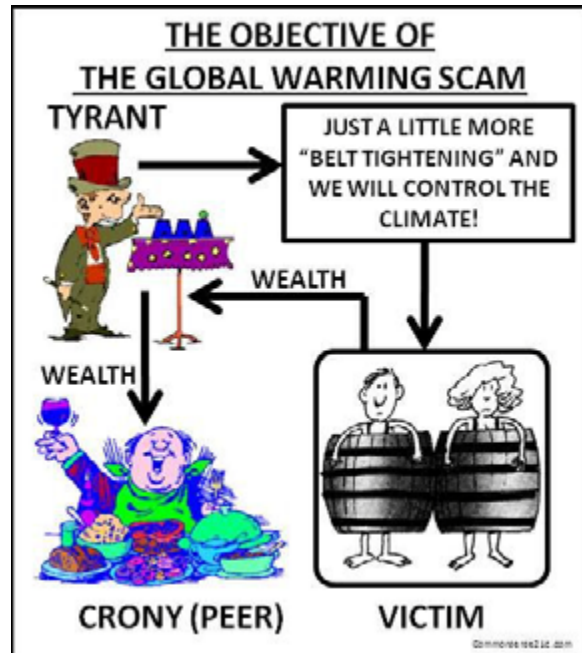

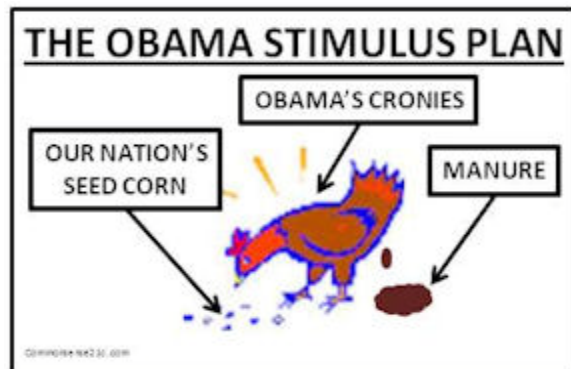

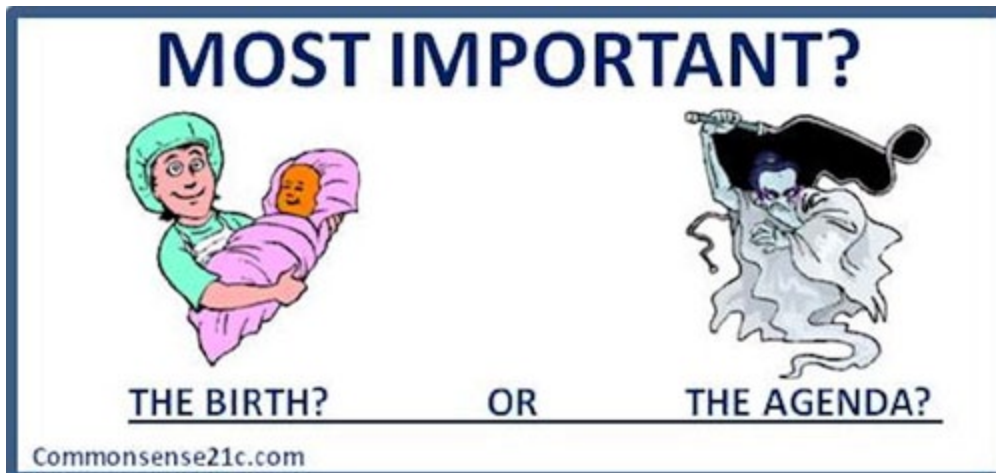

With no crop to harvest the farmer was unable to pay the property taxes on the farm. The government confiscated the farm for taxes and sold it at auction, leaving the farmer homeless

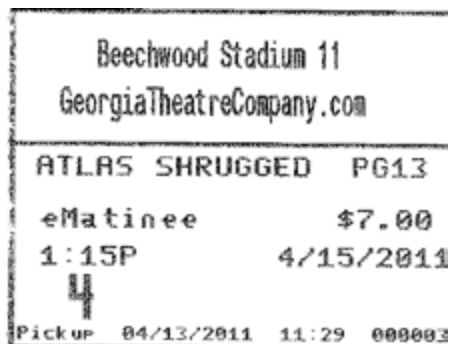
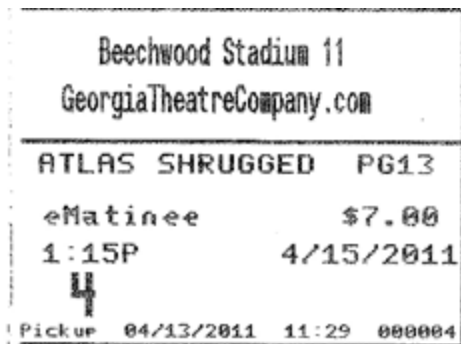
and destitute. Having no place to house the chickens, the ex farmer sold the chickens to the slaughterhouse and used the proceeds to survive until he could obtain welfare.

### **3/9/2011 THE TECHNOLOGY DIVIDEND-THE ENTREPRENEUR'S LEGACY PART 1**

"The technology dividend" is a term used in the book "*21<sup>st</sup> Century Common Sense*" to describe the increase in the Nation's wealth and general standard of living due to innovation (technological advances). Wealth is the goods and services required for human beings to survive, enhance their lives and invest in the future. Production of wealth requires freedom, labor, materials, energy and knowledge. To produce wealth in the quantity required for general prosperity, freedom is an absolute necessity, the greater the individual freedom, the more productive the economy. Many of the benefits of the technology dividend are derived by replacing or enhancing human effort with machines. The machines that augment human effort consume energy. Growth of the technology dividend requires cheap and abundant energy.

For thousands of years the quantity of wealth produced by mankind was stagnant. The tyrants oppressed the producer which suppressed innovation.

The Kings, Tribal Chiefs and their Peers, (henchmen) held the serfs in virtual slavery, confiscating most of the wealth the hapless serfs were able to produce. Whatever wealth was produced provided the rulers with what passed for luxury in the pre-Industrial Revolution World while the serfs survived on the scraps. Innovation was futile as any additional wealth produced was simply confiscated by the tyrants. Innovation was dangerous as inventions were often considered witchcraft or heresy, resulting in the punishment of the innovator.

For thousands of years, innovation was held in check by tyranny. It was not until the late 16<sup>th</sup> Century that curbing the tyrant's power provided a measure of individual freedom. Finally, innovation was tolerated. The "Industrial Revolution" was born and technology dividend began its growth.

There were sketches of steam engines dating back as far as the First Century. But over 1600 years were required to build the first piston steam engine. The first practical steam engine was a water pump. Over 70 years passed before James Watt produced a steam engine with enhanced efficiency that featured rotary motion. Mankind finally had access to a reliable and abundant source of mechanical energy and the industrial revolution went into high gear!

The nation's wealth is consumed by our survival, enhancement of our standard of living and investments in the economy. Of course, this wealth must be replenished as it is consumed. If the general standard of living is to be improved, the labor and material content of this consumed wealth must be reduced by innovation. Man cannot consume more than he produces. Any increase in the general standard of living must be preceded by an increase in productivity. Man's wealth is the goods services and investment necessary to maintain and enhance life. Creation of that wealth is limited by man's resources is limited.

The small but very important part of the nation's wealth is the investment in the economy. This investment is production and transportation facilities, scientific research, design and development of new products, and infrastructure. The selection of these investments highlights the difference between tyranny and capitalism. Under capitalism the entrepreneur selects a project on the basis of the profit it will produce and proceeds to procure the capital required to pursue the project by convincing investors that the project will produce a profit. The politician expends capital for the purpose of enhancing his political future. Which method of selecting the investment will provide the wealth to increase the general standard of living?

Almost all of the Nation's wealth has energy content. Any increase in the cost of energy increases the cost of creating wealth, reducing the general standard of living. Alternative energy cost more than primary energy. If alternative energy cost the same as primary energy, it would not be alternative energy. Government would not be necessary for alternative energy if it could be shown that the alternate to the energy source would be profitable.

The technology dividend increases the Nation's wealth by reducing its material, labor content while maintaining quality and function of that wealth, thus improving the general standard of living. Often, the reduction in labor and material content of products is accomplished by increasing the energy content of the product.

The growth of the technology dividend results from:

- The material cost of products is reduced while maintaining quality and function.
- The labor content of products is reduced due to increased productivity.
- The performance of the product is improved.
- New functions are added to the product increasing its value
- Reduction in cost of transporting the product to market.
- Invention of a new product that provides a function previously unavailable or replaces a more costly product.

Many inventions lead to whole new industries and functions not even considered at the time of the invention. Solid state electronics led to the economical computer and information technology. The functions of these industries were prohibitively expensive until the development of solid state electronics.

Increasing the quantity of dollars in circulation does not increase wealth; it simply redistributes the wealth to the recipients of the distributed dollars while penalizing all who own money. Over the long term, increasing the dollars and credit in circulation reduces the value of the dollar but maintaining the real value of wealth while reducing the material and labor content of that wealth increases the value of the dollar.

Some examples of the innovation or inventions that have enhanced our standard of living by reducing the labor and/or material content of wealth are:

- The steam engine
- The light bulb
- Radio & telegraph
- The Bessemer steel furnace
- Charles Martin Hall's process for refining aluminum
- Solid state electronics
- The computer
- The many advances in transportation technology
- John D Rockefeller's innovations in the petroleum industry

The technology dividend is the cornerstone of our modern economy. A little over 100 years ago the benchmark of individual productivity was the cultivation of 40 acres of land using a new form motive power. The farmer worked from dawn to dusk to produce the basic necessities of life.

Today, in the United States there is a 40 hour work week and most citizens enjoy air-conditioning, a personal vehicle, television, radio, a refrigerator, electric lights, the personal computer, a cell phone with enhanced capability, the ability to cross the continent in a matter of hours and access to a supermarket packed with food and a vastly increased life expectancy.

These luxuries are the accumulated results of the technology dividend. The accumulation of the technology dividend is wholly dependent upon the degree of individual freedom. Individual freedom is the hallmark of Capitalism.

### **2/1/2011 CAPITALISM AND THE SAFETY NET**

The issue of the safety net or welfare has been debated between the political left (controlled by wannabe tyrants) and conservatives since the early 1930s. It appears that the wannabe tyrants have won the debate and use the issue to advance their agenda. It is no accident that the political left has been able to expand its agenda using the issue of the safety net or welfare.

Since the "Safety Net" has been an integral part of our society for over 1000 years, it would seem that the question of whether or not a Safety Net will be part of our society has been settled. The questions that remain are how to configure the "Safety Net" to serve society's best interest and how do you justify the transfer of wealth to the indigent in a Capitalist society.

The wannabe tyrants see the safety net as an opportunity to increase their personal power. Manipulation of the safety net could be a valuable tool for increasing their constituency. The wannabe tyrants knew that their constituency was composed of:

- The Elite, those who believe that their greater intelligence and station in life gives them the right to use government force for their benefit.
- Those willing to accept the promise of unearned wealth and security in return for their liberty.
- Those dependent on the government for subsistence.

The elite, as a group, is a rather stagnant quantity. There is a limited amount of wealth available to purchase their allegiance and the elite require more than a few crumbs for their

support. Those willing to accept the promise of unearned wealth and security in return for their liberty are also limited as most people value their freedom and questioned the validity of the offer. Corruption of the educational system offers the best opportunity to increase this group. However, manipulation of the education system requires years to bear fruit. In the near-term, the wannabe tyrants' best chance of increasing their constituency is to increase the quantity of people dependent upon the government for their subsistence, those unable to produce the wealth required to sustain their lives.

The wannabe tyrants' tactic of supporting inflation continually increases the number of citizens receiving aid from the safety net. Inflation is the result of increasing the money supply and government rules and regulations that increase the cost of production of wealth or restricts the harvesting of natural resources. Inflation pushes the members of the lower middle class into poverty making them dependent upon the government for their survival.

The wannabe tyrants sold a multitude of welfare programs citing compassion for the downtrodden and the idea that "there, except for the grace of God go I." The welfare programs were structured so that once ensnared in the system, it was virtually impossible to regain one's independence. After all, escape from the welfare system might reduce the wannabe tyrant's constituency. An important feature of the welfare system was to encourage the indigent to have children, ensuring a steady increase in those dependent on the government for subsistence.

Inflation, coupled with the rules and regulations of the welfare system, assured the wannabe tyrants of a continuously growing constituency.

Conservatives have been spectacularly unsuccessful at preventing the wannabe tyrants from using the safety net – welfare issue to expand their agenda. government expenditures and very creative "revenue enhancement" provisions (sometimes called taxes and fines by us reactionaries).

The Health Care Reform Act was a case of misdirection because it promised access to health care for the poor and delivered tyranny to all. The real purpose was to extend government control over the individual, enhancing the power of the tyrants. The so called healthcare reform Bill was the culmination of over 120 years of assault on our freedom and the American Revolution. These laws made any successful entrepreneur subject to prosecution by the justice system. The mere prosecution under the antitrust laws could cost a fortune and disrupt the entrepreneur's business. Even if the defendant prevailed in court, the effect on the business could be devastating. The tyrant could use the threat of prosecution to extort political support from the entrepreneur. The same laws could be used to reward political cronies by providing them with a competitive advantage over the entrepreneur.

So the antitrust laws gave the tyrant virtual control over the successful entrepreneur.

In the late 1880s, the Interstate Commerce Commission (ICC) was created. The bureaucracy would expand rapidly, acquiring the power to legislate, prosecute, police, and act as judge and jury. Of course, the tyrants control the bureaucracy and this fourth branch of government could be used to extort political support or reward political cronies all at the expense of the economy and individual freedom.

Considerable amount of executive talent is required for compliance with the income tax code preventing the use of that talent for productive purposes.

The "technology dividend" is a term used in the book, *"21st Century Common Sense"* to describe the reduction in labor and material content of the gross domestic product that results from advances in technology. The progressive income tax, a tax on productivity, is a direct assault on the "technology dividend".

Because of the cost of compliance and the devastating effect on the "technology dividend" the real purpose of the progressive income tax cannot be to raise revenue for the government.

Those who advocate implementing the Fair Tax and scrapping the income and payroll taxes do so because they believe the Fair Tax will enhance the economy and of course, it would.

Goods and services must be produced before they can be consumed. Since the quantity of materials, labor and energy are limited, the quantity of these resources required to produce our products must be reduced to enable an increase the Gross Domestic Product (GDP). The per capita GDP must be increased to improve the general standard of living.

To create wealth and earn a profit, the entrepreneur uses science, technology, and innovation. The mechanism of creating wealth is the reduction of labor, material and/or energy content of products (wealth) while maintaining or increasing the value of that merchandise. The wealth that each of us must have to survive and enhance our lives.

An historic example of the "technology dividend" is the results of John D Rockefeller's Standard Oil during the late 1800s. Between 1865 and 1890, Standard Oil reduced the price of kerosene from \$0.58/ gallon to \$0.07.38/ a gallon. In the process Standard Oil created the basis for the modern petroleum industry. During that period kerosene was the primary source of lighting.

To produce the "technology dividend", the entrepreneur requires capital to build new businesses capable of creating wealth. The progressive income tax makes it much more difficult for the entrepreneur to obtain that capital. When the government imposes higher taxes on the entrepreneur, that profit is no longer available to build and grow the business. The progressive tax also makes it more difficult for the entrepreneur to obtain capital from the investor. If the government is going to take most of the profits, why should the investor risk his money?

When you eliminate or reduce the entrepreneur's access to capital, you reduce or eliminate the technology dividend. The technology dividend is the key to increasing our standard of living.

The progressive income tax is not the only way that the wannabe tyrants attack the technology dividend. The wannabe tyrants enact new rules and regulations that harass the entrepreneur with the objective of maintaining the "status quo" for the benefit of their political cronies or to extort political support from special interest. These activities are even more detrimental to the technology dividend than the progressive income tax but they are not nearly so obvious to the average citizen.

A Google search lists over 20 pages of "inflation calculators" three of the most popular inflation calculators list the inflation rate of between 24.6 and 27.71 from 1900 and 2007. In other words, \$1.00 in 1900 was worth around \$25.00 in 2007.

What happened? In the late 1800's and early 1900's four factors emerged that caused inflation to increase. These are:

- Creation of the "Fourth Branch of Government" the Bureaucracy
- Enacting and enforcing the Sherman Antitrust Act.
- Creation of the Federal Reserve
- Enacting the income tax
- Wars

How did these factors cause such erosion in the value of the dollar?
